2. Complete the absentee ballot request form and return it to your local election official. If you are unable to return the form, please contact your local election official for assistance.
3. Receive the absentee ballot from your local election official. If you are unable to receive the ballot, please contact your local election official for assistance.
4. Fill out the absentee ballot and return it to your local election official. If you are unable to return the ballot, please contact your local election official for assistance.
